Cadastral Template Project

I am delighted to advise that the Cadastral Template Project jointly developed by the Permanent Committee on GIS Infrastructure for Asia and the Pacific (PCGIAP) and the International Federation of Surveyors Commission 7 (Cadastre and Land Management) has received a United Nations mandate through the 16th United Nations Regional Cartographic Conference for Asia and the Pacific held in Japan on 14-18 July 2003. The Resolution is attached.

The United Nations mandate for the Cadastral Template Project is an important development to improve the efficiency and effectiveness of cadastral systems worldwide including a focus on the role of cadastres in national spatial data infrastructures. In simple terms the Cadastral Template provides a standard format to collect both descriptive and statistical data of the cadastral system of a specific country.

After several years' development the Cadastral Template has now been approved for use by all countries in the Asia-Pacific region under the direction of PCGIAP and by the country delegates to FIG Commission 7. The UN Resolution also endorses the desirability of seeking countries worldwide to complete the Template by collaboration with the United Nations Economic Commission for Europe Working Party on Land Administration (UNECE-WPLA), the United Nations Economic Commission for Africa through the Committee on Development Information (UNECA-CODI) and the UN-sponsored Permanent Committee on Geospatial Data Infrastructure for the Americas (PCIDEA).

The Cadastral Template Project has been coordinated through the Centre for Spatial Data Infrastructures and Land Administration, Department of Geomatics, The University of Melbourne, Australia, by myself, Mr. Daniel Steudler and Dr. Abbas Rajabifard, with the support of Professor Stig Enemark (Aalborg University, Denmark).
